

## WOW. WIN WITH OFFICE

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

**OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES, THE DISTRICT OF COLUMBIA, AND CANADA (EXCLUDING QUEBEC), WHO ARE EIGHTEEN (18) YEARS OLD OR OLDER AT THE TIME OF ENTRY.**

**VOID IN QUEBEC AND WHERE PROHIBITED OR RESTRICTED BY LAW.**

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins October 2, 2017 at 12:00 PM Eastern Time ("ET") and ends November 6, 2017 at 11:59:59 PM ET ("Sweepstakes Period"). The Sweepstakes will include the following five (5) entry periods (each an "Entry Period"):

Non-winning entries will carry forward into subsequent Entry Period. Sponsor's computer is the official clock of the Sweepstakes.

- 2. ELIGIBILITY:** The Sweepstakes is offered only to legal residents of the fifty (50) United States, the District of Columbia, and Canada (excluding Quebec) who are at least 18 years of age at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, and advertising, promotion and web design agencies (collectively, "Sweepstakes Entities") and members of the immediate family (mother, father, brothers, sisters, sons, daughters and spouse, regardless of where they reside) and household members of each such employee, officer, director, representative or agent whether or not related, are not eligible to enter or win. Void in Quebec, Puerto Rico, all United States Territories and Possessions and overseas military installations, outside of the United States and Canada, and where prohibited or restricted by law. All federal, state, provincial, and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and potential winners may be required to provide proof of identification and eligibility as required by Sponsors or Administrator. 3. **HOW TO PARTICIPATE:** During the Sweepstakes Period, an eligible entrant must visit <https://officewow.com> ("Website") and enter his/her email address. The eligible entrant must then follow the instructions to register by entering all information requested on the registration form including, but not limited to, his/her complete first and last name (no initials), complete residential address (P.O. Boxes are not accepted), city, state/province, ZIP/postal code, date of birth, and confirmation that entrant agrees to these Official Rules. An eligible entrant may then earn entries via the following methods:

- A. During the Sweepstakes Period, an eligible entrant will earn thirty (30) Sweepstakes entries by visiting an authorized retailer ("Authorized Retailer" – see Appendix for lists of Authorized Retailers for United States/District of Columbia entrants and Canada entrants), purchasing a qualifying product ("Qualifying Purchase" – see below), and following the instructions to upload the receipt at the Website. Eligible Qualifying Purchase products: Office 365 Home, Office 365 Personal, Office Home & Student 2016 for PC, Office Home & Student 2016 for Mac, Office Home & Business 2016 for PC, Office Home & Business 2016 for Mac, Office Professional 2016 for PC. **Only receipts from Authorized Retailers that include Qualifying Purchases will be eligible. Receipts from products purchased from third-party resellers through any Authorized Retailer website will not be accepted.** Qualifying Purchase and upload must both be completed during the Sweepstakes Period. Note: During the Sweepstakes Period, an eligible entrant may alternatively submit a Qualifying Purchase receipt by sending an email to [win@officewow.com](mailto:win@officewow.com) with the Qualifying Purchase receipt included as an attachment (note – individual retailers may offer alternate email addresses that may be used to submit as described above). The entrant will receive a reply email that includes a link to the Website. The entrant must follow the link and register if entrant has not already registered, as described above, to receive thirty (30) Sweepstakes entries (if entrant has already registered, entrant will receive thirty [30] Sweepstakes entries by submitting a valid Qualifying Purchase receipt via email). To receive entries by emailing a receipt, entrant must register during the Sweepstakes Period. - C. During the Sweepstakes Period, an eligible entrant will earn four (4) Sweepstakes entries by following the instructions at the Website to vote in a poll provided by Sponsor. Limit four (4) total Sweepstakes entries via this method (one [1] time responding to the poll).

Entrant will receive seven (7) entries at completion of the trivia game. Limit seven (7) total Sweepstakes entries via this method (one [1] time playing the trivia game).

During the Sweepstakes Period, using Facebook or Twitter, an entrant may invite other people to participate in the Sweepstakes by posting a link to his/her own Facebook wall or Twitter timeline ("Invitation Post"). Potential winners from Canada will be required to correctly answer a mathematically timed skill-testing question before being declared a winner (as further described in Section 6 below).
